SUPPLEMENTAL BID BULLETIN NO. 24-023

This Supplemental Bid Bulletin No. 24-023 is to amend or modify items in the Bid Documents and in response to the queries raised during the pre-bid conference conducted 12 November 2024 for “Provision of Security Services to UPOU Headquarters and UPOU Diliman Office from 1 January to 31 December 2025” to wit:

<p>1. Under Stability 1.1 Years of Experience. The security agency must have been continuously operating for at least five years and with at least three years of experience in campus security.</p> <p><i>“I am trying to lodge my appeal if this requirement is liberally reduced so that we can comply”.</i></p>	<p>There will be no change in the requirement.</p>
<p>2. Under Stability 1.6, Certification for DOLE Department Order no. 18-A, if I am not mistaken, it has been superseded by the DOLE D.O. No. 174-17.</p>	<p>Update: 1. Stability 1.6. With Certificate of Registration following Department of Labor and Employment Department Order No. 174, series of 2017</p> <p>- Updated Section VII. Technical Specifications and Section VIII. Checklist of Technical and Financial Documents are attached.</p>
<p>3. Should the bidder comply with DO 150-16 as part of the requirements?</p>	<p>DO 150-16 provides guidelines for favorable employment conditions for the guards. The Certificate of Registration, which is the documentary requirement for bidding, is governed by DO 174-17</p>
<p>4. About the Technical Parameters, Item No. 3. <i>“Since you used the term “contractor”, it means that we entered the contract already, so does it mean that items 3.1 to 3.6 are not needed to be submitted during bid opening?”</i></p>	<p><i>A Contractor</i> is interchangeably used with <i>Bidder</i>.</p> <p>All requirements stated in the checklist are to be submitted during the bid opening.</p>

<p>5. There will be changes in the Itemized Cost Breakdown/Bid Proposal in relation to non-application of increase in salary tranche effective April 2025 to Los Banos</p>	<p>An updated copy of the Itemized Cost Breakdown/Bid Proposal is attached.</p>
<p>6. <i>“Is it allowed to have a discount in the bid proposal?”</i></p>	<p>The UPOU allows ‘discounting’ since there is no provision under the rule that prohibits such.</p>
